Mike Cassidy made a motion to vote on whether to keep our service with AWEBCO at a cost of \$69 per month. The board feels this is too expensive and Lindsey advised that when she got into the web page it appeared they had not done much for us. On a roll call vote of AYES – 0 and NAYS – 6, the board agreed not to keep the service with AWEBCO. James is looking into Another company that would be \$15 per month.

The board discussed whether they should place a bid on the fire station building in

Road Committee: Mike advised he had called Derek Heidrick to plow after the last snow. When Mike got into town that evening the snow was melting so he called Derek and cancelled. The board addressed the need for some new street signs to help UPS deliver to proper homeowners. James will look into this.

The board discussed whether they should place a bid on the fire station building in Alvin. Mike Cassidy advised he had inspected the building. It needs a new roof, new overhead doors and a furnace. It would still be cost effective to purchase this building and do repairs as opposed to building a town hall building. Mike Cassidy made a motion and Brian Pettice seconded to make a sealed bid on the building. Lindsey Keummerle made a motion and Brian Pettice seconded to go into executive session to discuss the amount of the bid. Motion carried. Chad Dickison excused himself from the meeting since he was also interested in placing a bid. After discussion and amount was decided and there was a roll call vote with AYES – 4, NAYS – 1 and ABSTAIN – 1. The board also requested the clerk get a copy of the minutes from BCFPD last board neeting.

Water Works: James advised he had been in a meeting regarding the lead pipes but hasn't started anything yet. We received the Manager Report from Cooperative Advantage and they are still showing a balance due on the Scott Redden property of over \$300. They were advised in October that Scott had passed away and the service would be shut off. James thought he had turned the water off but will look into it.

Parks and Grounds; The new light at Homer Carter park will be installed in the parking lot tomorrow if it is not raining. The Easter basket giveaway is schedule for April 2 at the Christian Church. Rita is going ask Scott Cropper if he will be the Easter Bunny.

There being no further business to come before the board, on motion by Rita Roderick, seconded by chad D<u>ickison</u>, the meeting was adjourned at 8:00 p.m.
